### **History**

Citizens were becoming increasingly alarmed at the failure to neglect and forget about the "Sabbath Day." This group of people believed that with the increased number of immigrants to the city, it was being outstripped in its capacity to meet the needs of a moral and religious culture. Government and the law was also not working towards the continued reverence of the Sabbath. It was believed that, "The Sabbath became in many quarters… the gala-day of the godless; the harvest-day of avarice; the high-day of vice and crime."

The first meeting of the New York Sabbath Committee took place on April 1, 1857. The group consisted of a number of leading Christians. The Committee consisted of about twenty members connected with eight Christian denominations.

The group did not have grand plans to undertake extreme measures in society. Their primary goal was to remind the citizens of the importance of the Sabbath Day. They would do this via the pulpit, the press, and personal influence. Notable members include Philip Schaff.

The organization continued until at least the 1930's.
