Biography

Martha Letitia Edwards was a student at the University of Wisconsin, where in 1913 she submitted a thesis for the degree of Master of Arts. In 1916, Edwards submitted a thesis at the University of Wisconsin for a Doctor of Philosophy degree.

Edwards compiled this information to help students of American history locate material for the study of Indian missions. Due to sectarian bias and generalizations, accounts from a variety of denominations were used. Edwards believed it imperative that religious developments should be studied in connection with economic and political history.

Edwards kept three things in mind when compiling the research. The first was to collect material for the study of Indian missions which may shed light on the story of westward expansion. Secondly Edwards tried to arrange the material in the hopes of indicating the development of missionary organizations. Finally Edward attempted to show the connection between the religious organizations and the political authority.

Collection Scope and Content Note

This collection contains the 159 page loose typescript copy by Martha Letitia Edwards, created circa 1920. The denominations include Baptist; Catholic; Congregational; Friends; Methodist; Moravian; Presbyterian; Protestant Episcopal; and Interdenominational Societies including but not limited to the Algic Society and the Indian Mission Association.

The papers consist of the typescript copy in original page-numbered order.

Processing

Metal clips and staples were removed from materials and folded items were flattened. Materials were placed in new acid-free folders and boxes. Acidic items were separated from one another by interleaving with acid-free paper as needed.

Note – The collection is housed in the same box as MRL10: John Eliot.
