

#### Biography

Charles Augustus Briggs was born on January 15, 1841 in New York City, son of businessman Alanson Tuthill Briggs and Sarah Mead Berrian. He studied at the University of Virginia from 1857-1860 where he experienced a conversion. After joining New York's Seventh Regiment in Washington DC for a few months during the Civil War, Briggs then attended Union Theological Seminary, where he was taught by renowned faculty such as Edward Robinson and Henry Boynton Smith. In 1863 he left seminary to manage the Briggs family business, the largest barrel-making company in the USA, during an extended period of his father's ill-health.

Briggs married Julie Valentine Dobbs in 1865 and they had 7 children, five of whom were alive at the time of Charles Brigg's death in 1913: Emilie Grace Briggs, Agnes Briggs (Mrs Philip Ketteridge), Alanson Tuthill Briggs, Herbert Wilfrid Briggs and Olive M. Briggs.

He was licensed to preach by the First Presbytery of New York in April 1866 and in June of that year he and his wife traveled to Berlin where he studied for his doctorate at the University of Berlin with leading theologians and proponents of historical critical scholarship such as Isaac A. Dorner. He was later to recall Dorner in Berlin and Henry B. Smith at Union as the scholars and friends who were pivotal influences in his life. Returning to the United States in 1869, he was called to be the first pastor of the First Presbyterian Church of Roselle, New Jersey. He accepted an offer of appointment to Union Theological Seminar to teach as Professor of Hebrew and the cognate languages in 1874.

William Adams Brown, a student of Briggs and a future colleague, described him as a "walking encyclopedia, combining an essentially conservative theology with a critical scholarship."

The Modernism movement challenged the traditional and historic religious beliefs of denominations across the religious spectrum in the second half of the 19<sup>th</sup> Century. The Biblical criticism theories that emanated from German theological seminaries at the same time also drew religious groups into the turmoil. In 1883 Briggs wrote *Biblical Study: Its Principles, Methods and History*: a collection of previously published articles discussing biblical criticism.

In 1885, he published *American Presbyterianism: Its Origins and Early History*, challenging the traditional assumptions staunchly held by the Presbyterian Church in light of the Biblical criticism debate. He hoped to convey to his Presbyterian denomination that it was possible to investigate these new Biblical studies, be open to their conclusions, and not compromise their stance as faithful evangelical Presbyterians. The tools and the work of biblical criticism were not antithetical to theology, Briggs argued. They searched for a fuller understanding of the Bible and "need not be feared."

In 1890 Briggs became the first incumbent of the Edward Robinson Chair of Biblical Theology at Union Theological Seminary. His inaugural address on January 20th 1891 entitled "The Authority of Holy Scripture" informed and inflamed both sides of the modernism and biblical criticism debates with its outspokenness and force.

Criticism is at work with knife and fire.... Let us cut down everything that is dead and harmful; every kind of dead orthodoxy, every species of effete ecclesiasticism, all those dry and brittle fences that constitute denominationalism, and are the barriers to Christian unity. Let us remove every encumbrance out of the way for a new life; the life of God is moving throughout Christendom, and the springtime of a new age is about to come upon us.

In 1892 the Presbyterian Church charged Briggs with heresy and put him on trial. Briggs spoke in his own defense in four sessions and provided thorough examinations of all charges. Briggs was acquitted of the charges. The Committee on Prosecution then appealed to the General assembly meeting in Washington in 1893 and that appeal trial suspended him from the office of Presbyterian minister until he gave "satisfactory evidence of repentance." In order to avoid schism within the Presbyterian church Briggs continued as Presbyterian, preaching as a layman within the church for a further 5 years, before enacting his earlier plan to join the Episcopal Church. He was ordained as an Episcopal priest in 1899.

Briggs continued teaching and writing, and with co-writers Francis Brown and S.R. Driver, prepared the *Hebrew and English Lexicon*, thoroughly revised from earlier versions and commonly known by the initials *BDB*. It was published in 1905 and remains the gold standard for Hebrew studies in theological seminaries. It is worth noting that his daughter, Emilie Grace Briggs, made significant contributions as her father's amanuensis. She was the first woman to graduate from Union Theological Seminary and the first to obtain the Bachelor of Divinity in 1897. After Briggs' death in 1913, Emilie worked to complete and publish posthumously her father's unfinished works. She assumed the role of curator, spending many years organizing and preserving her father's sermons and correspondence with the intention of producing a biography of her father.

Briggs received honorary degrees of Doctor of Divinity from the College of New Jersey (1875), University of Edinburgh (1884), Williams College (1894), University of Glasgow (1901), and the D. Litt. from Oxford University also in 1901.

Charles Augustus Briggs died on June 8<sup>th</sup> 1913 as a result of pneumonia, which to the distress of his family had been mistakenly diagnosed as "brain fever."

#### **Collection Scope and Content Note**

This collection consists of correspondence, writings, personal documents, and heresy trial documents as well as photographs and memorabilia formerly created by or belonging to Charles A. Briggs. Much of the collection is in the handwriting of Emilie Grace Briggs through her role as amanuensis for her father. Charles Briggs' academic as well as pastoral life is represented by sermons, published research material, notes and research aids, bibliographic notes, and work notes for the Hebrew-English Lexicon revision.

Detailed and substantial material related to Briggs' heresy trial proceedings in the Presbyterian Church from 1891-1893 can be consulted here.

The collection is organized in 5 series:

- <u>Series 1: Correspondence, 1875-1913 (2 boxes, 12 horizontal boxes, 13.00 lin. ft.)</u> This series contains all of Briggs's personal correspondence, both loose-leaf and transcriptions of letters within a series of bound ledgers prepared and arranged by Emilie Briggs.
  - <u>Subseries 1A: Loose-leaf Correspondence, 1875-1913 (2 boxes, 1.00 lin. ft.)</u> This subseries consists of the remaining loose-leaf correspondence received by Briggs, arranged alphabetically by correspondents' name. This group of letters includes correspondence with S.R. Driver, Paul Sabatier and Friedrich von Hügel.

The majority of Brigg's correspondence will be found transcribed or abstracted within the Ledgers in Series 1B.

## • <u>Subseries 1B: Correspondence Ledgers, 1841-1913 (12 horizontal boxes, 12.00 lin. ft.)</u>

Subseries 1B consist of 12 handwritten ledgers of correspondence prepared by Briggs's daughter Emilie Grace Briggs. Representing the vast bulk of Charles Briggs's extant correspondence, the letters contained within the ledgers were transcribed from the originals by Emilie following her father's death in 1913.

She undertook this task in order to make the large amount of material which she was assembling for a planned (but never realized) biography of Briggs more manageable.

Upon Emilie's death in 1944, it is understood that her sister Mary Olive Briggs destroyed the original copies of the letters, assuming that they were now surplus to requirement. Whether all the letters destroyed by Mary had been previously transcribed is not known.

#### • Series 2: Writings, 1875-1913 (39 boxes, 19.50 lin. ft.)

This series contains Briggs's sermons, lectures and addresses, printed articles, notes and research aids, material related to the *Hebrew-English Lexicon*, and an assortment of bibliographies. It is divided into 6 subseries.

#### • Subseries 2A: Sermons (5 boxes, 2.50 lin. ft.)

Boxes 1-3, and part of box 4, contain sermons numbered in Charles Briggs's hand. Dates and locations where the sermons were preached are recorded on the title page of each sermon and many were preached more than once. Almost all of the sermons were preached during Briggs's tenure at Roselle, NJ, between 1869-1874. A minority of sermons between May 1866 and July 1889 were also preached at other times and places. Sermons 168-172 were preached at various locations and times from July 1882-July 1889.

Box 5 contains a separate series of numbered extempore sermons. This series dates primarily from the early 1870s, while Briggs was at Roselle. Other sermons in Boxes 4 and 5, which include untitled sermons, fragments, sermons arranged by Bible reference, and Sermons numbered 450-653, are either undated or date from the 1890s.

The sermons named as trial sermons in Box 4 are unrelated to the heresy trial. These are sermons preached by Briggs immediately following his graduation from UTS, and may have been produced in the course of obtaining a license to preach.

#### o Subseries 2B: Lectures and Addresses (1 box, 0.50 lin. ft.)

This Subseries consists primarily of Union Theological Seminary lectures and lecture notes used in classes on a variety of subjects related to biblical theology.

Intermixed are also a few course schedules and course outlines, seminar notes, and student rosters. Box 1 Folder 9 contains public lectures in manuscript or typescript, as well as syllabi and programs for public lecture series.

#### o Subseries 2C: Printed Articles (2 boxes, 1.00 lin. ft.)

The Subseries contains printed and/or published material by Briggs as well as published reviews of his works and articles about him. With respect to articles written by Briggs, It is not clear in every case whether all articles written by Briggs were published, but a journal title and date of publication is noted in many cases if this is not printed in the article itself. Box 2, f 3 contains dated book reviews written by Briggs.

#### o Subseries 2D: Notes and Research Aids (17 boxes, 8.50 lin. ft.)

The notes and research aids which form this subseries cover a wide range of topics. Some of the groups of notes consist of working drafts for publication at varying stages of completion. The papers are organized alphabetically according to the title or broad theme. There are many subthemes throughout the material not listed here, but specifically themed notes are grouped in insert folders wherever possible. However a broad theme such as "Being and Attributes of God," will encompasses several subthemes of material, such as "Attributes of God," "Unity of God," "Divine Spirit," "Divine Son," etc. within each given folder.

Box 17 of this series contains research material already bound within notebooks.

#### o Subseries 2E: Hebrew-English Lexicon (3 boxes, 1.50 lin. ft.)

Copious hand-written notes and material covering Briggs's contribution to the popular *Hebrew and English Lexicon of the Old Testament* (also known as *Brown-Driver-Briggs* or *B-D-B*) are included in this subseries. First published in 1892, and based upon the Hebrew-German lexicon of Wilhelm Gesenius, the Lexicon was edited by Briggs's Union Theological Seminary colleague Francis Brown, in co-operation with Briggs and the Oxford scholar Samuel Rolles Driver.

The material in this Subseries has been grouped by Hebrew letter. In some instances, the letter to which the material related was unclear. The folders have been arranged in Hebrew alphabetical order according to the letters available.

It may be noted that the handwriting of many entries for the Lexicon may be identified as that of daughter Emilie Grace Briggs, who was thanked for her work on this Lexicon in the preface to the jointly authored *Critical and exegetical commentary on the book of Psalms*, by Charles A. Briggs and Emilie G. Briggs, New York: C. Scribner's Sons, 1906-07. (International Critical Commentary series).

#### o Subseries 2F: Bibliographies (11 boxes, 5.50 lin. ft.)

Subseries 2F contains a collection of bibliographies produced by Emily Briggs for the use of Charles Augustus Briggs. One box consists of bibliographies bound in

notebooks and scrapbooks. The bibliographies appear to have been kept in the order created by Emilie and Charles. The first eight boxes are topically arranged and the majority relate to church history, church practice, ethics, and the history of biblical interpretation. The bibliographies in Box 9 are arranged alphabetically by last name. A significant amount of material in this group relates to liturgy, worship, Christian institutions, and the offices of the church, suggesting that some of the bibliographies may be connected to Emily Briggs's unpublished doctoral dissertation, "The Deaconess in the Ancient and Medieval Church: A Study in the History of Christian Institutions."

In order to maintain the original ordering of the bibliographies, topics have not been alphabetized, with the exception of the materials in Box 8 where the alphabetical scheme, introduced during previous processing, has been retained.

#### • Series 3: Personal, 1859-1913 (7 Boxes, 2 Horizontal Boxes, 1 Oversize Box, 7.25 lin. ft.)

Series 3 consists of a variety of personal material, ranging from Briggs's time as a student and as a faculty member at Union Theological Seminary, published material owned by Briggs with his own handwritten notes in the margins, photographs, and a set of honorary diplomas and various other certificates.

#### o Subseries 3A: Personal Materials (4 boxes, 2.00 lin. ft.)

The personal documents in Subseries 3A include historic documents and family trees for Briggs' family members dating back to seventeenth century, brief autobiographical material by and about Charles Briggs and university transcripts including material related to honors received by Briggs during his lifetime. Church documentation relating to the Episcopal Church material, including notices and orations related to Briggs's ordination, and his certificate of license can be consulted here.

Further information on organizational membership, conference invitations and Briggs's death notices are supplemented by bibliographic lists of books owned by Briggs or produced by him on index cards prepared by Emilie Briggs). A number of articles are in German.

#### o Subseries 3B: Union Papers (2 boxes, 0.75 lin. ft.)

Subseries 3B contain material both from Briggs's time as a student at Union and from his time on the faculty at Union. The student material consists of three lecture notebooks: one with notes on lectures by Thomas H. Skinner and two with notes on lectures by Henry Boynton Smith. The faculty related material consists of library materials, book seller records and receipts, documents pertaining to CAB's move from language chair to biblical theology chair; teaching statistics, documents regarding the enlargement of the seminar, course lists, inaugural addresses, etc.

- Subseries 3C: Annotated Published Materials (1 box, 0.50 lin. ft.)
  Subseries 3C consists of published, bound material, owned by Briggs, containing his own handwritten annotations.
- Subseries 3D: Photographs (2 horizontal boxes, 2.00 lin. ft.) Subseries 3D consists of photograph portraits of Charles Briggs during his career, Charles and Julia wedding portraits, photographs of Emilie Grace Briggs as a small child, and keepsake photographs acquired during travel.
- Subseries 3E: Oversize Personal Documents (1 oversize box, 2.00 lin. ft.) Subseries 3E consist of a variety of honorary degree and other certificates, two certificates of ordination from the Episcopal Diocese of New York and Briggs' passport.

#### • <u>Series 4: Presbyterian Church and Heresy Trials, 1870-1900 (10 Boxes, 31</u> <u>Horizontal Boxes, 43.50 lin. ft.)</u>

All of the material collected in this Series concerns the Presbyterian Church, which serves as the umbrella under which related topics - including Briggs's heresy trials, as actions perpetrated by the Church - are assembled.

#### Subseries 4A: Presbyterian Church (1 box, 0.50 lin. ft.)

Series 4A contains material related to the structure and organization of the Presbyterian Church, and includes correspondence, decrees, financial statements, articles of association, etc. Much of the material concerns the *New York Evangelist*, the weekly newspaper published by the Church until its closure in 1893; and *The Presbyterian Review*, the scholarly theological journal co-founded by Briggs, who served as one of the journal's two managing editors, in 1880.

 Subseries 4B: General Assembly Joint Meeting, 1891 (1 box, 0.50 lin. ft.) Subseries 4B consists of the minutes of a joint meeting of the Conference Committee of the Presbyterian General Assembly and the Union Theological Seminary Board of Directors held at UTS on October 28 and 29, 1891. The Committee met following the General Assembly's vote, taken at its May, 1891 meeting in Detroit, to disapprove of Briggs's appointment to a chair of Biblical Theology at Union.

# Subseries 4C: Revision Controversy, 1889-1892 (2 boxes, 1.00 lin. ft.) Series 4C contains publications from various authors in the form of press clippings, opinions, and academic articles relating to the Revision Controversy in the Presbyterian Church of the United States of America (the "northern" Presbyterian Church). Whilst the majority of these printed materials are concerned with the Controversy more generally, a number specifically address Briggs's arguments in favor of Revision. The material in Folders 5-7 of Box 2 comes from the New York publication *The Independent*.

- <u>Subseries 4D: Heresy Trial (5 boxes, 31 horizontal boxes, 41.00 lin. ft.)</u> This subseries consists of material directly related to the heresy proceedings against Briggs: minutes of proceedings from presbytery as well as General Assembly gatherings, objection notes, press clippings, etc. Also, there are various pamphlets, arguments, and speeches pertaining to the heresy trials authored by a number of contemporary theologians and commentators.
- <u>Subseries 4E: Public Responses to Inaugural Address (1 box, 0.50 lin. ft.)</u> Series 4E contains public responses Briggs's inaugural address in 1891.

#### • Series 5: General (4 boxes, 2.00 lin. ft.)

This small series contains annotated books and notebooks. Notable items include: Charles Briggs' Bible volumes with indications in his daughter Emilie's hand of sermons by her father; Two volumes of Dexter's Appendices listing publications by date on Congregationalism which trace the ordering of material for the Westminster, later McAlpin, collection in the UTS library; Notebook of lectures by Briggs and other faculty from 1880s; The Speech by Briggs at the opening of the UTS buildings in Morningside Heights in a publication covering the event.

#### Processing

Metal clips and staples were removed from materials and folded items were flattened. Materials were placed in new acid-free folders and boxes. Acidic items were separated from one another by interleaving with acid-free paper as needed. Bound volumes were secured with ties and wrapped in protective paper. Photographs were placed in Mylar. Oversize documents were flattened and placed in acid-free folders.

The series of documents from Briggs' daughter, Emilie Grace, and son, Anaston Briggs, which consisted of work to produce a commentary on Song of Songs had previously formed a late addition to the existing Charles Briggs Collection. These documents will now form a separate collection of papers on the understanding that Anaston and Emilie Briggs' work on this commentary was carried out following the death of their father.
